**GENERAL SQL PARSER
WARRANTY DISCLAIMER AND DISTRIBUTION LICENSE AGREEMENT**

This document includes warranty disclaimers (Part I) and a license agreement governing the distribution of General SQL Parser (Part II).

PART I. WARRANTY DISCLAIMER

No Warranty. The Software is made available by Gudu Software for reproduction and distribution "AS IS" without warranties or conditions of any kind, express or implied including but not limited to warranties or security, non-infringement and quiet enjoyment. GUDU SOFTWARE MAKES NO WARRANTIES, CONDITIONS, REPRESENTATIONS, OR TERMS (EXPRESS OR IMPLIED WHETHER BY STATUTE, COMMON LAW, CUSTOM, USAGE OR OTHERWISE) AS TO ANY MATTER INCLUDING WITHOUT LIMITATION, MERCHANTABILITY, INTEGRATION, SATISFACTORY QUALITY, OR FITNESS FOR ANY PARTICULAR PURPOSE. The foregoing exclusions and limitations will apply to the maximum extent permitted by applicable law, even if any remedy fails its essential purpose.

PART II. DISTRIBUTION LICENSE AGREEMENT

This is a contract between YOUR COMPANY NAME HERE. ("Distributor") and Gudu Software. By distributing the distributable version of the Software provided to Distributor by Gudu Software, Distributor agrees to the terms of this agreement. This agreement is effective against Gudu Software only if Distributor has provided Gudu Software with information about its intended distribution and Gudu Software has confirmed its acceptance of this agreement in writing to Distributor. If you enter into this agreement in error, you may rescind your acceptance prior to distributing the Software by returning this agreement.

1. Definitions.

"Gudu Software" means a corporation organized and existing under the laws of China, having its registered office at No 206 Lane 631 West GuMei Rd Shanghai China.

"Distributor Product" or "Distributor Service" means product that has integrated General SQL Parser library.

"Effective Date" means the date that Gudu Software confirms its acceptance of this agreement in writing to Distributor.

"Intranet" means a secure internal web site or server system that is accessible only to Distributor's employees, contractors, or other persons granted access to Distributor's internal networks in the furtherance of Distributor's normal course of business.

"Software" means General SQL Parser library and Updates to the foregoing software products provided to Distributor by Gudu Software for distribution under this agreement.

"Updates" means upgrades, modified versions, updates, additions, and copies to or of the Software provided to Distributor by Gudu Software for distribution under this agreement.

2. License, Requirements, Restrictions.

2.1 License. Subject to the terms of this agreement, including the requirements and restrictions below, and only for purposes of achieving the distribution of General SQL Parser, Gudu Software grants Distributor a non-exclusive, non-transferable, worldwide, customer-based license to reproduce and distribute the Software, in all cases solely for the complete installation and use of the unmodified Software. In addition, Gudu grants Distributor the right to provide access to the Software to its customers.

2.2 Distribution. Distributor may do any of the following:

(a) Make one copy of an image of the Software on a Distributor computer file server for the purpose of downloading and installing the Software onto computers within Distributor's Intranet, for internal use only;

(b) Distribute the Software on a standalone basis only on physical media (such as CD-ROMs, DVDs, hard disk, etc.); and

(c) Distribute the Software as a part of or with Distributor Product or Distributor Service (i) through electronic means such as electronic download-- including, without limitation, electronic software download-- for example bundled in Distributor's installer, which in turn, is downloaded through the Internet and (ii) on physical media (such as CD-ROMs, DVDs, hard disk, etc.).

(d) The distribution license is based on per customer. There is no limitation on how many copies of this library can be deployed on the customer-side.

The rights granted above shall terminate immediately in the event of Distributor's breach of any provision of this agreement.

2.3 Requirements.

(a) Distributable Version, Access. Distributor will distribute only the version of the Software (with its corresponding installer) provided to Distributor by Gudu Software upon completion of this agreement. Distributor will not distribute any version of the Software found elsewhere. Gudu Software may provide Distributor with access to the distributable version of the Software via electronic download at a specified non-public website. Distributor shall not disclose the location of such website to any third party.

2.4 Restrictions.

(a) No Unauthorized Distribution. Unless Distributor has separate written permission from Gudu Software, it will not distribute the Software in any manner not permitted by Section 2.1 or 2.2. For example, Distributor shall not distribute any installer or installer files in any manner not permitted by such sections.

(b) No Transfer. Distributor may not rent, lease, sublicense, assign or transfer its rights under this agreement, or authorize all or any portion of the Software to be copied except as may be expressly permitted herein. Provided, however, that Gudu is deemed to have consented to any such assignment to an affiliate of Distributor.

(c) No Modification, No Reverse Engineering. Distributor must not reverse engineer, decompile, or disassemble the Software, except and only to the extent applicable law expressly permits the activity.

3. Trademark Use.

Gudu Software hereby grants to Distributor, and Distributor accepts, a worldwide, non-exclusive, non-transferable, personal right to use and distribute, under the terms of this agreement, the " Gudu Software General SQL Parser".

4. Intellectual Property Ownership, Copyright Protection. The Software and any authorized copies that Distributor makes are the intellectual property of and are owned by Gudu Software and its suppliers. The structure, organization and code of the Software are the valuable trade secrets and confidential information of Gudu Software and its suppliers. The Software is protected by law, including without limitation the copyright laws of the United States and other countries, and by international treaty provisions. Except as expressly stated herein, this agreement does not grant Distributor any intellectual property rights in the Software and all rights not expressly granted are reserved by Gudu Software and its suppliers.

5. Technical Support. Gudu Software shall not be obligated to provide any support to Distributor, its distributors, or end-users.

6. Defense of Intellectual Property Infringement Claims.

(a) Coverage. Gudu agrees to defend, at Gudu's expense, Distributor in a lawsuit or other judicial action, and pay to Distributor the amount of any adverse final judgment (or settlement that Gudu consents to) from the lawsuit or judicial action, for any third party claims that Software

- (1)** misappropriates a trade secret,
- (2)** infringes any copyrights or trademark rights, or
- (3)** infringes any patents.

Each of these is individually referred to in this Master Agreement as a "Claim."

(b) Gudu will also reimburse Distributor for any costs reasonably incurred by Distributor in its defense of any such third party claims prior to the filing of such lawsuit or judicial action.

(c) Gudu will not settle any action without prior written consent by Distributor.

7. Limitation of Liability. EXCEPT FOR INFRINGEMENT OF INTELLECTUAL PROPERTY CLAIMS, IN NO EVENT WILL EITHER PARTY TO THIS AGREEMENT BE LIABLE TO THE OTHER FOR ANY CONSEQUENTIAL, INDIRECT, INCIDENTAL DAMAGES, OR ANY LOST PROFITS OR LOST SAVINGS, EVEN IF A GUDU SOFTWARE REPRESENTATIVE HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH LOSS, DAMAGES, CLAIMS OR COSTS OR FOR ANY CLAIM BY ANY THIRD PARTY. THE FOREGOING LIMITATIONS AND EXCLUSIONS APPLY TO THE EXTENT PERMITTED BY APPLICABLE LAW IN DISTRIBUTOR'S JURISDICTION.

Nothing contained in this agreement limits Gudu Software's or its suppliers' liability to distributor in the event of death or personal injury resulting from negligence or for the tort of deceit (fraud). Gudu Software is acting on behalf of its suppliers for the purpose of disclaiming, excluding and/or limiting obligations, warranties and liability as provided in this agreement, but in no other respects and for no other purpose.
